COVID 19 PROTOCOLS

Our goal is to provide a safe, calm, inclusive and positive environment for all participants. We appreciate unexpected situations could arise on the day that may require action that is meant to protect our dancers, judges, volunteers and other participants.

This event is being held in compliance with any provincial health and safety orders, as well as facility requirements for Covid-19.

1. Public Health requirements will be continuously evaluated, and participants will be informed of any Covid-19 protocols prior to the event through social media and email.
2. In the absence of any Public Health Order mandates, the organizing committee for (*name of event*) strongly encourage participants to:
 - a. Wear a mask for your own protection and the protection of others (dancers continue to have a choice whether to wear a mask while competing)
 - b. Maintain physical distancing wherever possible
 - c. Frequent hand hygiene

Upon registering for this event and immediately prior to the event, you agree to the requirements and recommendations of any National, Provincial and local Public Health (Southwestern) and other governmental authorities as well as any requirements from *Embro and Zorra Community Centre/Township of Zorra* which may be in effect at the time of the event, as it pertains to the Covid-19 Coronavirus and to adopt all necessary measures to those effects.

Flat fee registration: Primary \$22.00, Beginner/Novice \$27.00, Intermediate/Premier \$30.00. Fees include \$1.00 for 2022 SDCCS Surcharge and \$1.00 for postage and handling of the dancer's gate pass/confirmation of entry. Dancers must present their R.S.O.B.H.D. Reg. Card in order to receive their dance number. Dancing takes place under the rules of R.S.O.B.H.D. The decision of the judge is final. No discussion or correspondence can be entered into between a judge and a competitor or the parent or guardian regarding a judge's decision. All verbal announcements will take precedence over the written program.
